






In late summer the McDonough County Animal Shelter received a letter and a plague from the Best Friends Animal Society – the national leader in the "no kill" movement.



August 2024, Saying Goodbye

Vankan Matching Funds \$10,000 Fundraiser in Memory of Sparky and to Celebrate all Adopted Shelter Animals

How the Covid Pandemic Changed Three Lives in a Magnificent Way (by Gloria Caldwell Vankan)

Spanky was a small, young Pitbull mix when animal control seized him from a brutal situation where his sister froze to death beside him in their outdoor kennel in the winter of 2014. Our Humane Society of Nelson County, Virginia took him, and he lived there 2,031 days—years longer than any dog ever had. He was smart, cuddly, and proudly learned all commands shelter staff taught him.

Since 2008, my husband Ed and I had been full time volunteers there and upon Spanky's arrival we concentrated on him. As the years ticked by, we knew his chances of ever getting adopted were slim. He had Pitbull in his blood, was afraid of other dogs and strangers, and needed a calm home where he could feel safe and his fears could be lovingly managed. Shelter employees had active homes with other animals and kids, so they couldn't adopt him.

After our dog Bessie died in early 2019, we began taking Spanky home for day trips and weekends. He loved being out of the shelter, running in our fenced yard, sunbathing, and cuddling with us. His house manners were excellent, and he delighted our souls, but our social lives were too active for us to adopt him.

Having just become senior citizens when Covid happened, we put our social lives on hold and stopped going to the shelter in order to social distance, when it dawned on us. We no longer had other animals or children visiting, and we excelled at managing Spanky's fears, so we committed to fostering him until the pandemic ended.

Once he moved in, our home was full of joy and dog kisses enough to ease our worries about what the pandemic might do to the world. We decided to live, laugh, and love in the moments we still had on Earth. We spoiled Spanky with belly rubs, snacks and sunbaths, but his main joy in life became hiking and exploring with Ed twice each day. Spanky was a self-proclaimed "crusader" on the trail, though his safety zone required that Ed always pick him up and hold him close until any perceived threat subsided when they met other people or dogs. Spanky knew his fate was always safest in Ed's arms and together they logged over 5,000 miles of trail.

Spanky was twelve when a mass started rapidly growing between the toes of his right hind foot. Our vet suspected cancer, said a biopsy would be painful and debilitating, and suggested a more humane solution may be to remove his foot. We knew Spanky would not understand that. While we pondered what to do, Spanky broke his left forepaw, causing him to cry when it touched the ground. Our hearts broke as he looked up at us with a confused and scared look on his face. Our little crusader had lost his ability to walk.

Reality hit us hard and fast. We could not hamper Spanky's biggest joy in life by crippling him with the removal of a paw or two, so out of a deep love and respect for him, we made the humane decision, best described as a horrific decision, to help him leave his broken body the next day.

The next morning Ed held him up as Spanky devoured a hamburger breakfast, then carried him on their favorite hiking trail, and then carried him to Spanky's outdoor sunbed. We sat on our porch holding each other and sobbing as our eyes drank in the beautiful vision of our precious Spanky still in his dog form, enjoying his last Earthly sunbath.

Doing what Spanky needed from us most on August 29, 2024, as our vet lovingly worked her magic, Ed held him closely one last time, as I cradled his face in my hands and promised him we would see him again when it became time for us to step into the light. Spanky and I held eye contact until his exquisite soul took flight, and his newly empty body became unusually heavy in Ed's arms.

Something about Spanky's appreciativeness in finally having a home stretched our hearts to the max. He lived with us for four and a half years and of course we foster failed. Spanky left for the Rainbow Bridge with our last name tattooed on his soul, as we pretty much knew he would the moment we began fostering him.
